#### **LOCATION**

The property is situated on Cornhill within the busy commercial town of Bridgwater Somerset some 10 miles to the north of Taunton and approximately 35 miles south of Bristol.

The town has a population of approximately 40,000 people, excellent access to the M5 motorway at junction 23 and 24 with the A38 trunk road passing through the town.

There is a strong industrial base with Hinkley Point due to expand and large industrial estates to the north and south of the town underpinned by such employers as Gerber Foods and Wiseman Dairies amongst numerous other successful commercial companies.

The property's location is on the fringe of the pedestrianised Fore Street but accessible to passing traffic driving around the Cornhill to High Street, there are future development proposals for the town centre including a scheme which may involve a new Tesco Supermarket. It is also close to the prestigious King Square and the offices of Sedgemoor District Council with its many employees.

#### THE BUSINESS

This is a popular well established and desirable business with significant potential. It enjoys a light-hearted atmosphere creating good service to a very loyal customer base.

It is renown for selling a wide range of top quality handmade sandwiches and baguettes in addition to its large range of cheeses, homemade cakes and quiches, hams, eggs, bacon and dairy products plus a range of pasties and pies, biscuits and preserves. It also has a self-service salad bar with everything made on the premises.

The potential for this business lies in providing outside catering and sandwich deliveries to the many small and large businesses in the area. The opportunities for this are enormous.
